USU's Sustainability Infrastructure and Programs - Alexi Lamm

Briefed the FSEC on Greenhouse Gas Inventory. Two thirds of the green gases are heating and cooling on the campuses. The Goal is to become carbon neutral. Seventeen faculty members attended a one-day workshop and discussed USU sustainability resources. If the 17 faculty members update their syllabi and include sustainability in their courses approximately 2,000 students will be impacted by this knowledge and commitment. Buildings on campus are helping to support the sustainability initiative. Housing is participating in energy wars and they are competing to reduce energy. The Aggie commuter club works with transportation and provides benefits to those willing to bus or bike to campus. This initiative also includes a ride share program. Over 5000 individuals on campus have registered. Drive electric in northern Utah is collaborating with Weber State University on this program. Ratings are submitted every 3 years.
