No-Test Days Policy

A five-day period designated as "no-test" days precedes final examinations. During this time, no major examinations, including final examinations will be given in order that students may concentrate on classwork, the completion of special assignments, writing projects, and other preparation for duly scheduled final examinations. Approved exceptions include: final papers, weekly chapter quizzes, quizzes, projects, examinations associated with a lab that does not meet during final examinations, and final examinations for broadcast courses.

Proposed Addition to No-Test Week Policy

A five-day period designated as "no-test" days precedes final examinations. During this time, no assignment, quiz, project, paper, or exam can be due that is worth more than 15 percent of a student's final grade for the class. The sole exception to this policy is if the professor does not give a final examination, assignment, quiz, project, or paper during finals week. If no final examination, assignment, quiz, project, or paper is given during finals week, any assignment, quiz, project, paper, or exam may be due during No-Test Week

Proposed Addition to No-Test Week Policy

A five-day period designated as "no-test" days precedes final examinations. During this time, no assignment, quiz, project, paper, or exam can be due **that is worth more than 15 percent of a student's final grade for the class. The sole exception to this policy is if the professor does not give a final examination, assignment, quiz, project, or paper during finals week.** If no final examination, assignment, quiz, project, or paper is given during finals week, any assignment, quiz, project, paper, or exam may be due during No-Test Week
