Section I: Request

The Department of Wildland Resources proposes to restructure its MS and PhD in Forestry by dropping the existing specializations in Forest Biology and in Forest Economics and Policy.

Section II: Need

This restructure is necessary to allow the Department of Wildland Resources to drop specializations that are redundant or are not used by Forestry MS and PhD students and faculty in the department. Forestry graduate students who are interested in forest biology are getting Ecology MS and PhD degrees with a focus on Forest Ecology (an R401-5 has been filed that will recognize this focus by creating a specialization in forest ecology within our Ecology MS and PhD degrees). Forest economics and policy is not an area of emphasis in the Wildland Resources Department – we have no faculty in these areas in our department. Therefore we propose to drop the Forest Economics and Policy specialization because it is not used. Our proposed change will not affect the rigor of the Forestry MS or PhD programs or the courses taken. It will simplify our program marketing by dropping a specialization that is not used (Forest Biology), and will clarify our program marketing by dropping a specialization that is not available (Forest Economics and Policy).

Section III: Institutional Impact

The proposed program restructure will simplify and clarify the Wildland Resources Department's MS and PhD program in Forestry. This change will not affect our administrative structures, nor will it change faculty or staff requirements, or required facilities. The required coursework will not change, and the academic requirements of the masters and doctoral program will not be affected or changed.

No additional costs are anticipated as a result of this change.
