### **Gen Ed Assessment**

*First year of General Education Assessment Plan was successful in terms of faculty engagement, but also a steep learning curve. This year is being treated as a “pilot” year where we refine processes. Data from the first year is noisy so in lieu of an outcomes report, Michael Torrens and Harrison Kleiner will be producing and sharing a “case study” report on lessons learned and modifications for next academic year. Modifications are on the technological side of things, particularly how faculty flag assignments in Canvas. There is optimism that at this time next year we will have meaningful and actionable data from GE Assessment. The General Education Assessment Plan that was approved included a step to second score student artifacts. While the accreditors did give USU a clean bill of health, but they will be doing a follow up in the fall and will expect USU follows through with the full plan. Academic and Instructional Services (AIS) will pull a sampling of student artifacts from each breadth area for the area committees to second score. Since the focus will be on learning about the process this year, there will be an abbreviated second scoring of 10-20 artifacts. Harrison will write something up to give to the area chairs and then let them talk with their committee members. All bread areas with the exception of communications literacy will be tasked with second scoring. The hope is that area committees can complete the review by the end of May.*
